 - 4.1 Attendance Matters, Anglophone South School District Lori Wall and Paul Smith

Mayor Bishop welcomed Lori Wall, Principal of Sussex Regional High School, and Paul Smith, Director of Schools (Hampton). Mr. Smith thanked Council for the opportunity to speak. Ms. Wall and Mr. Smith noted the following: Attendance Matters is an initiative of the Anglophone South School District born from a meeting with the New Brunswick Teachers Association; attendance and tardiness are issues in grades K-12; student attendance can be improved; the goal is to have more students attend school on a daily basis; grades 9-12 have five periods a day as opposed to morning and afternoon schedules for K-8; the reasons for attending and not attending school are similar throughout grades K-12; focus groups with principals and students were used to identify challenges; and Attendance Matters is focused on spreading the word through posters, brochures, videos etc. that communities care about

student attendance. Mr. Smith and Ms. Wall thanked Rothesay Council for promoting schools on the Town's website and invited any questions.

Council made the following inquiries: is attendance a bigger problem for boys than girls; are there available methods to provide a more welcoming environment for students; why bullying, and pressure and exhaustion from extracurricular activities were not included in the list of reasons students do not attend school; is attendance looked at when discussing young offenders in the criminal justice system; and what can the municipality do? Ms. Wall and Mr. Smith responded with the following comments: data does show that boys attend school less frequently on a regular basis then girls however, the difference is not a significant amount; there is a safe room created for students as well as mental health appointments provided within schools; in New Brunswick there is a distance education program available online in school or at home; the focus groups did not mention bullying, or pressure and exhaustion; there are various reasons young offenders are ordered mandatory attendance however, there is a small percentage assigned that sentence; and the municipality can help by promoting Attendance Matters and asking students outside of school during school hours to return to their classes. Mayor Bishop thanked Mr. Smith and Ms. Wall for their presentation.
