4.1 Cherry Brook Zoo Lynda Collrin, BSC, MSc Director Zoo Development/Primatologist (See Item 9.1) Alice O'Neill, Chairperson

Ms. O'Neill and Ms. Collrin appeared before Council and gave a presentation with respect to the Cherry Brook Zoo. Ms. O'Neill made the following comments: strong volunteer base with over 4900 hours, Cherry Brook Zoo was the first in Atlantic Canada to receive accreditation from CAZA (1991), summer 2012 will go through the accreditation process again, regional communities have given support in the past, budget has been reduced by 20% and a new strategic plan will be developed. Ms. Collrin made the following comments: growth includes expansions of programs and services which requires new buildings, additional businesses have been introduced to increase revenues, the focus is conservation, research and education, collaboration with international commissions, breeding program needs to be enhanced and the Zoo is one of the top ten attractions in the region and the province.

Deputy Mayor MacDonald asked about attendance figures. Ms. Collrin indicated there was a reduction of about 10,000 in 2010 mainly because of bad weather. On questioning, she noted a presentation had been made to the City of Saint John but they had not been advised yet whether funding would be provided. Counc. Cochrane questioned how the deficit would be addressed. Ms. Collrin advised a corporate sponsor had recently come onboard and the new strategic plan will focus on obtaining corporate support.

Mayor Bishop thanked Ms. O'Neill and Ms. Collrin for their presentation.

From a procedural point of view, all motions should be in the affirmative and should Council wish, it can vote against it and defeat the motion. Counc. Cochrane advised the Planning Advisory Committee recommended against setting a hearing but should Council decide to do so, it also recommended against authorizing the amending development agreement. Counc. Mullett questioned if it was a totally different proposal.

DDS Drescher advised the original development was for semi-detached and four unit housing under condominium ownership, on one large lot. The amendment is to change to individual units on individual lots. She further advised the amendment will reduce the number of units from 22 to 19. It was noted the Municipal Plan amendment and Zoning By-law amendment were already approved. The change in the proposal requires an amendment to the agreement, which must be considered after a public hearing is held.

It was suggested it is possible to prepare a schematic plan and then re-tender for the next phase. The second phase of the project will be the arena renovation and the third phase will be the fieldhouse project. Town Manager Jarvie advised the recommendation was based on the analysis of four senior staff members. Counc. Shea advised the Parks and Recreation Committee reviewed the initial Request for Proposals, but not the submissions. He did not see the need to delay the project by waiting for another month for the Committee to review the submissions.

5 December 2011 Memorandum from Susan Johnson, Treasurer

Treasurer Johnson gave a brief presentation with respect to the Utility Capital and Operating Budgets, along with the General Capital and Operating Budgets. The Utility Capital Budget totals \$1.265 million and the total Operating Budget is \$2,433,131. Sewer rates will increase to \$285 and water rates will remain the same. The total General Fund Capital Budget will be \$8.9 million and the Operating Budget will be \$15,900,000.

Mayor Bishop noted the Town has managed its finances well, particularly with an increase in fire and police budgets, along with the comEX transit services. He noted the debt-service cost is 6.5% and the proposed tax rate will remain at \$1.1900.
