Mayor Bishop called the Public Hearing to order at 7:30 p.m. and gave instructions to those in attendance, noting the legislative process and advising the hearing was duly advertised. He indicated if there were no objections, the hearings would be held concurrently.

Counc. Shea declared a conflict of interest and left the meeting room.

DDS Drescher gave a brief presentation outlining the proposal to rezone 14 and 20 Rosedale Avenue, identified as PID#s 30269062 and 30266088, respectfully, from single family residential to two family to allow for construction of semi-detached dwellings. She noted the

Mayor Bishop called three times for those wishing to speak in opposition to the proposal. Mrs. Irene Sutton 10 Rosedale Avenue and Mr. John Chambers 6 Rosedale Avenue, spoke in opposition. The following comments were made: concern about possible road widening as 10 Rosedale Avenue uses the front area of their lot for vehicle parking, will the development use well water or Town water, varying road widths along Rosedale Avenue, the new exit from Cochrane's parking area is creating traffic issues, the need for a streetlight and the location of railway ties at the intersection of Rosedale Avenue and Robinson Road is creating some sight issues and drainage issues. Mayor Bishop noted there are no plans to widen Rosedale Avenue.

Mr. Shea noted road widening would be under the Town's responsibility and further noted JPJ Enterprises spent \$60,000 to widen the upper end of Rosedale Avenue and install storm and sanitary sewer. He further noted the properties are currently approved for single family development and the proposal is for two buildings with smaller footprints than an average single family home, and clients are normally single family or retired couples typically with one vehicle. Mr. Shea advised the NBPower lines will be underground, the lots will be nicely landscaped and they will be on private wells as Town water is not available in the area.

There was a lengthy discussion with respect to the property situate 83 Hampton Road. It is unclear whether the property is connected to the Town water system and there is concern with a cross-connection and possible contamination. It was noted the building does not need to be sprinklered if smaller units and fire walls are used in construction. The property owner paid the connection fees and advised the property is connected but does not draw from the Town water system, indicating the valve has never been opened. DDS Drescher noted the intent of the agreement is the developer is obliged to connect but it does not say "shall" connect. She advised she did not view the actual connection but the information she has indicates the property is connected. There was discussion with respect to the current By-law requirements and whether the \$5000 warranty is for the roadwork or connection to/use of Town water. It was further noted no meter has been installed. Mr. Bamford advised the Provincial plumbing Open Session Meeting Minutes

MOVED by Deputy Mayor MacDonald and seconded by Counc. Cochrane the request for the security release for 83 Hampton Road be tabled pending receipt of certification from the Provincial plumbing inspector and confirmation as to whether the property is connected to the Town water system.

ON THE QUESTION:

There was some discussion with respect to the cost, the best time to do the work and whether it could be done by Town staff. Director of Recreation Services Jensen advised the Fall is the best time to complete the work that will involve sodding, some tree planting and removal and some additional fill. He noted six companies were contacted and he spoke with all of them but only one submitted a response. Town Manager Jarvie advised the Parks Department is short-staffed and while they do complete some tree planting, this is a more concentrated project.
