There was a lengthy discussion with respect to the intent of the scholarship, the recommendation from the Finance Committee and subsequent motion of Council. Mayor Bishop advised he spoke with Martha Zed and noted the following: the request was \$10,000/yr for five years with the intent a student would be selected in the first year and assuming all criteria is met (including marks) it would continue for the four year program and in the fifth year a new student would be selected; the \$12,000/yr for four years is usually when an individual or corporation provides an endowment; there is no time limit on the motion; if a relationship is established with a student

and they sign an intent to return to the community, the scholarship is renewed based on marks; the difference between scholarships and bursaries and whether to provide for one year or multiple years and to one student or different students.


