Mayor Bishop called the meeting to order at 8:00 p.m. and welcomed Councillor-Elect Blair MacDonald. The Clerk was requested to administer to the Oath of Office.

Mayor Bishop welcomed all Councillors for the new term of Rothesay Council. He noted Counc. Young was recently recognized with the national Lifetime Achievement Award from the Radio and Television News Directors Association, indicating there are very few recipients of this award across the country.

Mayor Bishop noted Brian Haddock from Rothesay Park School will be travelling to the

Historic National Heritage Fair in Victoria, BC this summer.

Mayor Bishop noted congratulatory letters had been received from MP Paul Zed, MP Rob Moore, Minister Jack Keir, Enterprise Saint John Chair Bob Manning, the Mayor of Bathurst, the Provincial Capital Commission and David Emmerson at UNBSJ.

Counc. Mullett advised she had received complaints from residents about the recent municipal election and the fact there was only one polling station for the entire Town. She further indicated a number of residents advised they did not vote because they were not aware of the location at the Bill McGuire Memorial Centre. Counc. Cochrane noted there was no signage posted at the former locations.

### ON THE QUESTION:

There was general discussion with respect to guarantees on asphalt contracts. DO Hatcher advised testing is done daily at the asphalt plant and core samples taken. He further noted there is typically a one year warranty period. Deputy Mayor MacDonald requested clarification on the expected life of roadways under Town specifications. DO Hatcher indicated there are a number of factors, including: construction of the road bed and the type and volume of traffic. He further noted the objective is to balance the asphalt program to meet the needs of the community within the budget.

DO Hatcher further indicated the cost of petroleum has severely impacted the tender costs, noting in a 24 hour period between the two tenders before Council there was an increase of \$12.00/tonne.

## ON THE QUESTION:

DO Hatcher indicated the Kingswood Tank was constructed in 1980 and was decommissioned when the McLachlan tank was commissioned. The Kingswood Tank was inspected and is structurally fine but it was determined there is lead in the paint and its removal would require full containment and is cost-prohibitive. The tank does have value as a location for antennas and radars for both Town and Police communications.
