Deputy Mayor Artiss indicated he was not in favour of requiring the developer to install a sidewalk along the edge of his properties on Sierra Avenue. He further noted it would be dependent on the Town undertaking its work first, which may be approved in the 2009 Capital Budget. Deputy Mayor Artiss noted usually with new development the charges are charged back to the homeowners by the developer. Counc. Kilfoil concurred, noting the developer did not agree with the requirement and, if Council wanted the project to proceed, the clause should be removed.
