Mayor Bishop called the regular meeting to order at 8:00 pm.

APPROVAL OF MINUTES Regular Meeting – September 14, 2009

1.1 Business Arising from Minutes

Mayor Bishop requested an update on the Renforth Wharf tender. DO Hatcher advised it is in the process of being re-tendered and it is hoped to get part of the work done in 2009.

Deputy Mayor MacDonald requested an update on the Dunedin Road fire event with respect to theoretical causes and the time of the call. Town Manager Jarvie advised the Police Chief has not responded with respect to the time of the call and the Deputy Chief has no additional information. Mayor Bishop requested the Town Manager to obtain answers for next month's meeting. Counc. Gallagher Jette asked under what authority is the report privileged.

3. **OPENING REMARKS OF COUNCIL**

Mayor Bishop noted Senator John Wallace and MLA Margaret-Ann Blaney were in attendance at the meeting. He further noted Council had a good meeting with Oakville Acre residents last week at Rothesay High School and the strategies and recommendations will be reviewed later in the agenda.

Deputy Mayor MacDonald noted Mayor Bishop recently received an award from UMNB for 36 years of service as an elected official and is the second longest serving in New Brunswick. Mayor Legacy from Atholville has 40 years of service.

4. **DELEGATIONS**

4.1 KV Chamber of Commerce Phil Brodersen, President

Phil Brodersen, President – KVCC gave a presentation to Council with respect to matters identified by Chamber members, following the request for same by Mayors Bishop and Driscoll. They focused on signage, beautification and traffic. The Chamber has some suggestions and recommendations and is requesting an action plan within 3 months and ongoing discussions with the Town.

Mayor Bishop thanked Mr. Brodersen for his presentation and advised the Town is willing to work with the Chamber to continue to make Rothesay a desirable place to live.

4.2 Symphony New Brunswick Dr. Thomas Condon

Dr. Thomas Condon thanked Council for the opportunity to appear before them on behalf of Symphony New Brunswick (SNB) Inc. and Symphony New Brunswick Foundation. The request before Council is for an operating grant of \$1000 for the 2009-2010 season and a pledge of \$10,000 to the capital campaign, over a five year period.

Dr. Condon spoke to the background, activities and future of SNB. He outlined the capital campaign "VIVO" and advised the intent is to raise an endowment fund of \$2.5 million to add 5 full-time professional brass and woodwind musicians to the current 4 fulltime string members. Dr. Condon outlined funding received from other levels of government and grants from Heritage Canada and ACOA.

Mayor Bishop thanked Dr. Condon for his presentation.

4.3 40 Developmental Asset Survey Thelma Messer, SD6 Charles Jensen, Rothesay – Recreation

Thelma Messer gave a brief presentation to Council with respect to the 40 Developmental Asset Survey School District 6 will be completing, with the support of Atlantic Health Sciences Corporation. She noted an initial survey of the entire district had been completed in 2002, with Kennebecasis Valley students identifying 19.1/40. Mrs. Messer advised the full report from Sussex Corner to Rothesay would be made available to the Town. However, the Town could request the statistics for the Kennebecasis Valley as a separate report. The cost is \$500 which could be shared with Quispamsis. Charles Jensen advised the report can be used as measuring tool to gauge the impact of various projects the Town participates in, such as the Big Rothesay Read. He noted the Master Recreation Plan emphasizes the importance of engaging the youth in the community.

Mayor Bishop thanked Mrs. Messer and Mr. Jensen for their presentation.

4.4 Scott Avenue residents Joy Clowater

Joy Clowater appeared before Council and gave a brief presentation with respect to the residents at 10 Scott Avenue. She gave a summary of the residents who live in her building and commented on the sense of family throughout the building. Ms. Clowater noted they work together to do maintenance work in the building and also in the garden area behind the building. Ms. Clowater advised they had a paper petition containing 126 names and an online petition containing 185 names. She advised the residents are not against the project but are against the location on Scott Avenue.

Mayor Bishop thanked Ms. Clowater for her presentation. Counc. Gallagher Jette noted

she had a more comprehensive understanding of the residents affected.

MOVED by Counc. Gallagher Jette and seconded by Deputy Mayor MacDonald this Council not proceed with plans which would displace residents of Scott Avenue by purchasing the apartments on Scott Avenue.

ON THE OUESTION:

Counc. Shea suggested an amendment to the motion to reflect the earlier discussion; that "at this time" be included in the motion. Mayor Bishop noted some weeks ago Council endorsed the Master Recreation Plan in principle. He advised Council still supports the main recommendations but are not prepared to proceed with the property purchases on Scott Avenue at this time.

Mayor Bishop indicated this is an example of democracy at work. He stated the owners advised they were not interested in selling the properties and Council has now heard from the residents this evening.

MOVED by Counc. Shea and seconded by Counc. Gallagher Jette the words, "at this time" be added to the end of the motion.

ON THE OUESTION:

Counc. Gallagher Jette noted it is the wish of this Council not to proceed with the property acquisition but councils are never precluded from reviewing any action. She further noted this council could not speak for future councils.

Amending motion CARRIED.

NAY vote recorded from Counc. Cochrane.

Main motion, as amended CARRIED.

Mr. Warren Mahar, Scott Avenue, expressed concern with the wording "at this time". Mayor Bishop indicated one can "never say never". He noted Council is sympathetic to the residents in the area and this Council will not purchase the properties in the near future but they cannot speak for future councils.

There was a brief discussion with respect to \$750 per lot for cash in lieu of land for public purposes. DDS Drescher noted the policy had been discussed at a working session of Council.
