## 3. OPENING REMARKS OF COUNCIL

Mayor Bishop advised he received a letter of thanks from Jill Logan, Special Events Coordinator for St. Joseph's Hospital Foundation, for in-kind contributions from Rothesay for the annual Dragon Boat Festival. He also noted he attended the opening of King Pie in the Fairvale Mall with Councs. Cochrane and Shea.

Mayor Bishop advised a letter of thanks had been received from Mr. and Mrs. Roy on Wedgewood Drive thanking the Town for their help in resolving their water issue.

### 4. **DELEGATIONS**

# 4.1 Imperial Theatre Ron Outerbridge, Campaign Cabinet Member

Presentation (see Item 9.2)

Mr. Outerbridge appeared before Council and gave a presentation on behalf of the Imperial Theatre. He advised Council the Theatre had undertaken a \$2.5 million Capital Campaign in early spring to address the following: defective cladding on the stage house, outdated technology and repair and replacement of sections of the interior. Mr. Outerbridge noted a presentation had been made to the Greater Saint John Regional Facilities Commission, who advised capital funding requests need to be addressed directly to local municipal councils.

Mr. Outerbridge requested the support of Rothesay Council by committing to \$10,000

over five years for a total commitment of \$50,000. Counc. Cochrane requested clarification on the use of the endowment fund which is from a surcharge on tickets. Mr. Peter Smith, General Manager, indicated the interest from the fund goes back to the theatre in operating and the fund itself is used for rental client assistant grants. He also noted the campaign is both a theatre and foundation campaign but government contributions will go to the theatre only.

Mayor Bishop thanked Mr. Outerbridge for his presentation.

# **4.2 Saint John Theatre Company** Stephen Tobias

Presentation (see Item 9.3)

Stephen Tobias appeared before Council and gave a presentation on behalf of the Saint John Theatre Company. He noted the Company is the largest client of the Imperial Theatre and have been performing an annual main stage series since 1994. Mr. Tobias outlined the various projects supported by the Company, including: a guest artist program, mentorship and training program, strong outreach programs, annual literacy campaign and a recent partnership with the KVPlayers.

Mr. Tobias noted the organization has grown in scope in the past 18 years and needs infrastructure to support future growth and succession planning. A building was purchased which requires a \$1.4 million retrofit and the group has raised \$1.2 million. The Company is currently occupying the building in its unfinished state and requires an immediate investment of approximately \$40,000-\$50,000 to finish the ground floor. Mr. Tobias requested the support of Rothesay Council by committing to \$2,500 over the next three years for a total commitment of \$7,500.

Mayor Bishop thanked Mr. Tobias for his presentation and asked if Mr. Bob Doherty wished to make a comment. Mr. Doherty noted the goal is to ensure the theatre is not just for this generation but to ensure its longevity for our children and grandchildren.

### 4.3 Rothesay Recreation Committee

Bill McGuire, Chair Charles Jensen, Director of Recreation Services

Presentation (see Item 9.4)

Mr. Bill McGuire advised Council the Parks and Recreation Committee was proposing the Town undertake a review of recreation needs for the community to determine how best to resolve the existing issues of serving recreation needs with limited facilities. He introduced Mr. Charles Jensen, Director of Recreation Services who gave a presentation to Council. Mr. Jensen outlined the following: existing facilities, current demands, balancing demand and supply to meet various needs within the community, specific projects that are underway or recently completed and possible future projects. Mr. Jensen indicated the committee had a vision of "recreation and leisure opportunities for citizens of all ages, interests and abilities" and further outlined key reasons to invest in recreation projects, possible choices and recommendations of the committee. Mr. Jensen advised the committee was ready to move forward in establishing a five to ten year plan and was seeking Council's approval.

The following questions were raised by Council: partnering with other communities, requesting public input, a list of priorities, specific timeline for budgeting purposes and the use of a consultant. Mr. Jensen advised the committee is willing to look at partnering with other communities and organizations and will be seeking public input.

He further indicated it is anticipated the assessment can be done internally and there will likely be no cost this year. He advised the intent is to have something together to present publicly in conjunction with the Municipal Plan. Counc. Shea indicated the committee is seeking some direction from Council and is hoping to start working on the project immediately.

## ON THE OUESTION:

It was noted a traffic study had been done on Rothesay Park Road and no evidence of speeding had been found. Deputy Mayor MacDonald suggested "Children Playing" for the area. DO Hatcher indicated that type of signage is usually used in the area of parks and playgrounds and serves no regulatory value. Counc. Cochrane indicated subsequent requests would be received for numerous areas throughout the Town. DO Hatcher advised an amendment to the By-law would be required to reduce the speed along Rothesay Park Road, currently set at 40 Km/hr. He further noted it would then become an enforcement issue. The traffic study report was given to the Public Works and Infrastructure Committee and provided to Council last month. A request was made to forward the report to the residents in the area. Counc. Gallagher Jette indicated there are unique characteristics specific to Rothesay Park Road and further investigation should be undertaken and perhaps other streets in the community should be reviewed as well.

Cochrane commented on the loss of a staff member in the Water Operations Department and suggested if the Town pays for the training, staff be required to reimburse the Town if they do not stay for a certain lengthy of time. DO Hatcher indicated premiums are being paid by other employers. Mayor Bishop indicated the Personnel Committee will consider the request.

Deputy Mayor MacDonald indicated he would be supporting the motion because hockey players in Rothesay need ice time and if that need can be fulfilled for \$2.8 million rather than

\$15 million, it makes sense. Counc. Shea advised he would be voting against the motion for the reasons already stated, noting Quispamsis has already indicated they would not accept the offer so why make it. Counc. Mullett advised she would be voting against the motion because the proposal did not include a board to oversee the facility so Quispamsis would build, own and operate the facility with no input from Rothesay. Counc. Cochrane noted he seconded the motion in September but the subsequent discussions in the media were insulting and he would be voting against the motion. Deputy Mayor MacDonald indicated the offer was intended to be a counter-offer and not the end of negotiations.
