Mayor Grant called the meeting to order at 6:00 p.m. and noted there was a motion on the floor from the January 14, 2019 meeting.

#### 1. UNFINISHED BUSINESS

#### 1.1 Rothesay Arena

December 2018 Letter from residents RE: Request for a Public Meeting Mayor Grant read the motion on the floor from the January 14, 2019 Council meeting:

**MOVED** by Deputy Mayor Alexander and seconded by Counc. Wells Council schedule a public open house/presentation to show appropriate financials and plans on a renovated versus new arena in order to allow the public and stakeholders to provide meaningful and direct input on how they would like the Town to move forward regarding the rink.

Deputy Mayor Alexander commented in light of the collaborative effort by Council last week, he requested permission to withdraw his motion at this time. Mayor Grant asked if there were any objections. There being none, the motion was withdrawn.

# 3.1 Rothesay Arena

25 January 2019 Memorandum from Town Manager Jarvie

**MOVED** by Counc. McGuire and seconded by Deputy Mayor Alexander Rothesay Council supports the construction of a new facility on Scott Avenue to replace the Rothesay Arena; the project is to have a construction budget of \$7.5 million and is to include a standard ice surface (200x85 foot) and, *if possible*, a walking track; and further that Council expects to issue a request for proposals in March and the provincial and federal governments will be asked for financial assistance for the project.

# ON THE QUESTION:

The following comments were made: Council has made a positive and significant step forward with this decision that sends a positive message to residents, shows restraint and addresses needs, not wants; can the walking track be separated from the motion or separated in the request for proposals should the cost come in significantly higher than building an ice surface only; will a cut-off date be set if provincial and federal funding is not received and what decision will be made; the facility should be a community building for all to access and not only an ice surface; the need to be open to the funding requests of other area municipalities and maintaining the costs at \$7.5 million.

Town Manager Jarvie advised it will be a Council decision if the funding is not received from other levels of government as to whether the project will proceed without funding; noting other municipalities have received significantly more funding than Rothesay is seeking. Mayor Grant noted this decision will give clear direction, allow for lobbying with the other levels of government and will be monitored as it proceeds.

#### Amending motion:

**MOVED** by Counc. Brenan and seconded by Counc. Mackay French the words, "if possible," be inserted before the words "a walking track".
