## FREE Snowshoe Rentals at River and Trail Outdoor Company

- Adult & youth snowshoes are available for rent during Fundy Winterfest (February 1<sup>st</sup> – March 10<sup>th</sup>, 2024)
- Snowshoes can be **RESERVED** & picked up at River and Trail Outdoor Company (133 Hampton Road, Rothesay)
- **Snowshoes MUST be returned the day after pick up**
- A \$50 per pair cash deposit or credit card authorization will be collected at the time of pick up. This deposit will be refunded once the snowshoes are returned in the same condition they were when picked up.
- A copy of photo identification will also be collected at the time of rental.

### Terms of Agreement:

1. *Snowshoes will be picked up and dropped off by the user at River and Trail Outdoor Company located at 133 Hampton Road in Rothesay.*
  - **PICK UP:**
    - i. Monday to Saturday: After 1030am
    - ii. Sunday 1230pm
  - **RETURN:**
    - i. Monday to Saturday: 930am
    - ii. Sunday: 12pm
2. *The renter will return snowshoes in the same condition in which they were received the day after pick up. The renter is responsible for any and all damages incurred beyond normal wear and tear. In the event a snowshoe is damaged, lost, stolen or returned late, partial or the full deposit amount will not be refunded.*
3. **RESERVATION REQUIRED:** *Snowshoes may be reserved by calling (506) 849-7717 or visiting the store. Reserved snowshoes must be picked up Monday-Saturday after 10:30pm and Sunday after 12:30pm. Rented snowshoes must be returned Monday-Saturday at 9:30am and Sunday at 12pm.*
4. **RECOGNITION OF RISK;** Renter expressly acknowledges that snowshoeing is an activity with inherent risks of injury to persons and property; Renter is aware of those risks and understands them. Renter alone has determined the sufficiency of any safety gear or other precautions that Renter decides to take to minimize the risks of the activity. No party related to Lessor, including Owner and Employees, has made any representations regarding the safety of, or the risks of, the activity. Renter expressly assumes the risks of the activity.
