WHEREAS Rail Safety Week is to be held across Canada from September 23 to 29, 2024;

WHEREAS, 229 railway crossing and trespassing incidents occurred in Canada in 2023; resulting in 66 avoidable fatalities and 39 avoidable serious injuries;

WHEREAS, educating and informing the public about rail safety (reminding the public that railway rights-of-way are private property, enhancing public awareness of the dangers associated with highway rail grade crossings, ensuring pedestrians and motorists are looking and listening while near railways, and obeying established traffic laws) will reduce the number of avoidable fatalities and injuries caused by incidents involving trains and citizens; and

WHEREAS, Operation Lifesaver is a public/private partnership whose aim is to work with the public, rail industry, governments, police services, media and others to raise rail safety awareness;

WHEREAS, CN and Operation Lifesaver have requested City Council adopt this resolution in support of its ongoing efforts to raise awareness, save lives and prevent injuries in communities, including our municipality.

Deputy Mayor Alexander reviewed the discussion on Kingshurst Lane. He highlighted that traffic speeds were monitored and the majority were found to be within the speed limit. However, the Committee discussed that the 40km speed limit may be too fast for the road and traffic calming measures may be beneficial.

9.2 Bedrock Well Investigation

7 August 2024

Report prepared by DO McLean

MOVED by Counc. Lewis and seconded by Counc. Boyle Council accept the revised proposal submitted by Hydrostrata Engineering & Environmental, in the amount of \$89,870.80 plus HST, to perform a hydrogeological investigation and assessment of an existing unidentified Bedrock Well in the Carpenter Pond Wellfield.

ON THE QUESTION:

Mayor Grant summarized the report for the public. Town Manager Jarvie spoke of ground water vs. surface water, noting the latter is less efficient to treat. He explained as growth and development of the Town rises, so does the need for more water, therefore these water exploration projects will continue in the future. Close proximity to existing water sources is preferred as there are more costs associated with transporting water to the treatment facility from greater distances. In response to an inquiry, Town Manager Jarvie explained that the location of TH90-1 was not identified clearly in past well logs, and if it was capped and covered over, may not be easy to find.
