# CMHC Housing Accelerator Fund Application – Round II

Treasurer MacDonald advised that a second round of funding is available. Staff have prepared an application for roughly \$6 million dollars and recommend Council approve submission. However, if successful, some terms may have to be negotiated.

- 6. Create affordable housing density bonuses

### 9.1 W-2024-001 Water Treatment Plant Upgrade: Contract Award

4 September 2024 Report prepared by DO McLean

DO McLean explained that the project is to upgrade pumps and controllers to facilitate the installation of a third treatment train at the McGuire Road Water Treatment Facility. A five year spending plan will be discussed during the 2025 budget process to complete the project.

McGuire Council award Contract W-2024-00l: Water Treatment Plant Upgrade to the low tenderer, Select Mechanical Inc., at the tendered price of \$304,750.00 (including HST), as calculated based on estimated quantities and further that the Mayor and Town Clerk be authorized to execute the necessary contract documents.

### 9.2 Contract T-2024-004 Salt Shed Expansion – Master Drive

DO McLean advised a recommendation was made earlier in the spring to seek quotations. It is an unbudgeted project but necessary to centralize the materials at the Master Drive facility and remove them from their proximity to the Town's watershed. Staff believe the cost of the project is manageable within the Town's Capital Reserve.
