PUBLIC HEARING A By-law Respecting the Stopping Up and Closing Permanently

Public Hearing – Clark Road and Salmon Crescent Minutes -2-

21 October 2024

Mayor Grant invited DO McLean to give a presentation.

DO McLean addressed some confusion mentioned by members of the public. He explained that the technical wording for the process is to "Stop Up and Close portions of the Road Right-of-Way". To clarify further, he stated the intent is not to change the flow, function, or existing footprint of the physical roads but instead apply an administrative correction. Using an aerial map image, he demonstrated that the legal road right-of-way does not align with the physical road, and instead impedes upon two houses. He referenced improvements made to the Clark Road/Gondola Point Road intersection, noting the expansive right-of-way under discussion is not needed and can be converted to a separate parcel which could be transferred to the homeowners.

Mayor Grant thanked DO McLean for his presentation and invited questions from Council.

Counc. Shea asked for clarification, mentioning that this process would create a parcel of land that the Town owns but does not need, and could be transferred to the homeowners. DO McLean noted this is correct but is subject to a decision of Council. Counc. Lewis noted this would be a positive outcome for the two property owners.

Susan Hogan, a member of the public, appreciated the clarification, noting she had concerns that closing portions of the physical road could impact access/egress and worsen existing dangerous conditions related to traffic speed and sightlines.

Mayor Grant called three times for those wishing to speak against the proposal. Hearing none, Mayor Grant called three times for those wishing to speak in favour of the proposal. No one came forward.

3. Adjournment

Mayor Grant thanked all in attendance, and the public hearing adjourned at 7:17 p.m.
