3. OPENING REMARKS OF COUNCIL

Mayor Grant shared the following opening remarks:

- Condolences to the family and friends of Mrs. Ann King, former Deputy Mayor of Rothesay from 1983-1995. Visitation is on November 29th, and the Celebration of Life will be on November 30th. Rothesay flags will be lowered during this time.
- Congratulations to the new Premier Susan Holt and MLAs Alison Townsend, Aaron Kennedy, and John Herron.
- Announcement of the Annual Kennebecasis Valley Santa Claus Parade on November 30th at 6:00 p.m.

Counc. McGuire was impressed by the turnout on the Rothesay Common for the annual Remembrance Day ceremony. Several community members paid respects despite the wind and rain.

3.1 Declaration of Conflict of Interest

Counc. Mackay French declared a conflict of interest for Items 9.1.1 7 Stack Road (PID 30231765), and 9.1.2 By-law 3-24 (Salmon Crescent and Clark Road) owing to her absence at the Public Hearings.

Deputy Mayor Alexander declared a conflict of interest for Item 7.8 Planning Advisory Committee (7 Jersey Lane).

4. **DELEGATIONS**

4.1 Storm Drainage - Goldie Court/Scotiabank Alice Holden (see Item 9.2.1)

Mayor Grant welcomed Mrs. Holden. Mrs. Holden explained that she is back at Council because it has been 14 months, and the problem has not been resolved. The property has been in her family since 1961, and problems only began during construction work for 5 Brock Court. There have been several delays owing to a lack of quorum for a Works and Utilities meeting, and weather/seasonal construction deadlines. She mentioned retaining a lawyer that sent a notice to the Town requesting action. She relayed that work was done but can only be described as a "band-aid fix". Subsequently, work was tendered, and a contract was awarded in June 2024. In September it was determined a WAWA permit was required and was still not obtained in October. She concluded by asking for a status update.

DO McLean responded to Mrs. Holden's request, and other Council inquiries with the following: staff have gone through all the necessary steps – securing the easement, remedial work in the meantime, and submitting all information for the WAWA permit; the WAWA permit will be issued once Ducks Unlimited confirms compensation was received (which has slowed the process); the contractor is willing to complete the work and the intent is to do so once the WAWA permit is received, but this is weather dependent; staff have contacted the Department of Environment regularly for updates; the timeline for completion is estimated at 2-3 weeks; and it is not recommended that portions of the project be started (where the WAWA permit is not required) as this could create issues for other properties.

Council and staff shared the Holden's frustration, noting that delays owing to WAWA permit processes are not uncommon for projects.

Mayor Grant thanked Mrs. Holden, and the Holdens left the meeting.

4.2 Kennebecasis Regional Police Force (KRPF) Police Chief Gourdeau (see Item 9.2.2) Mayor Grant welcomed Police Chief Gourdeau. Chief Gourdeau explained that he is here to fulfill a new initiative to meet with the two town councils regularly to answer any questions.

Council inquired, and Chief Gourdeau provided responses on:

Fireworks – not a lot of complaints are received, and there are challenges with enforcement if the complaint is not related to public property (ex. access to private property).

Distracted Driving – special operations are conducted to combat distracted driving, however there are nuances in the court system which makes proving these violations difficult.

Changes under Chief Gourdeau's management – the addition of four front-line positions; a K9 Unit; a Human Resources position; an IT Specialist; a Finance Officer; a Strategic Plan; improvements to service delivery, crime prevention, and officer wellness initiatives; a productive relationship between the Police Force and Board; acquisition of new equipment; expansion of services to assist other organizations; a focus on regular skill improvement; recognition of member achievements; and well-deserved promotions.

Main themes in the survey were outgrowing the space available in the Rothesay Hive, accessibility, and housing (need for smaller housing options – ex. cluster housing). Staff reported submitting a proposal to the Dalhousie University Planning School for assistance with developing a plan for the former ballfield on Scribner Crescent. Staff are waiting to see if the students are interested in pursuing the project. Discussion ensued on trying to convey the Town's interest in diverse housing options, such as cluster housing, to developers. It was noted this can sometimes be done through development incentives in by-laws.
