3. OPENING REMARKS OF COUNCIL

Mayor Grant wished all a happy holiday season and all the best in 2025. She continued by sharing the following opening remarks:

- The Mayor's Annual Tree Lighting has been postponed to December 18th due to expected heavy rain
- The ice surface on the Rothesay Common opened on Saturday
- Appreciation for all staff, Council, and members of the public involved with the Annual Kennebecasis Valley Santa Claus Parade the event was a great success and ended with a view of the new lights at Town Hall

Mayor Grant announced that it is Town Manager Jarvie's last Council meeting after 27 years as Town Manager. Town Manager Jarvie was thanked for his long-standing service, attendance at 450+ Council meetings, and dedication to ensuring the Town is in excellent financial shape, abreast of the times, and a preferred place to live. She mentioned that he will remain with the Town but in another capacity. Town Manager Jarvie thanked Council and extended appreciation to Council and Town staff for all their support over the years.

Councs. 3.1 Declaration of Conflict of Interest

Counc. Mackay French declared a conflict of interest for Items 8.5 7 Stack Road (PID 30231765), and 8.6 By-law 3-24 (Salmon Crescent and Clark Road) owing to her absence at the Public Hearings.

4. **DELEGATIONS**

4.1 2029 Canada Games Bid Nick Cameron, Envision Saint John (see Item 9.1.1)

Mayor Grant welcomed Mr. Cameron. Mr. Cameron introduced himself as a Project Manager with Envision Saint John. He spoke of the bid, noting: it began through the Fundy Regional Service Commission (FRSC); it has been discussed for a year; the deadline for the bid submission is end of January 2025; a decision is expected in the spring (March or April); the Canada Games Bid Committee may return in February to revisit the venues; the sports remain confidential as they are subject to change before the announcement in the spring; MOUs from host communities are required in the bid submission; the MOU is not legally binding but rather a precursor for a future agreement; once the bid is successful a Host Society will be created with a Board and staff that will be responsible for operation plans and to facilitate work necessary before the 2029 event.

Council inquired about composition of the Board, and if other cities are bidding. Mr. Cameron noted the Board will be decided in consultation with the FRSC, and will include representation from the public, especially those with helpful knowledge and expertise. For instance, he shared that Bill McMackin is a member of the Bid Committee for the region. He explained that it is considered a non-competitive bid. The Canada Games circulate through the provinces and in 2029 it will be New Brunswick's turn. Fredericton, Moncton, and Saint John were invited to bid but Fredericton declined and Moncton and Saint John decided to submit a joint bid.

Mayor Grant thanked Mr. Cameron, noting the matter will be dealt with later on the agenda. Mr. Cameron thanked Council and left the meeting.

Shea Council accept the submission from AJW Mechanical for the installation of a ducted heat pump system for the McGuire Road Water Treatment Plant in the amount of \$35,223.35 including HST and further that the Director of Operations be authorized to issue a purchase order in that regard.
